Failure to comply with club rules, guidelines and requirements will remove eligibility for 2005 Aprilia Contingency.

National Mille class Contingency Program Rules:

Requirements:

Riders Must compete on a 2003 RSV Mille / RSV Mille R, 2004 & 2005 RSVR / Factory / Nera, or 2003, 2004, 2005 RSV Tuono / Racing / Factory. *Mille SP is not allowed.*

- 1) All Motorcycles must display a 6 x 3 inch Aprilia Logo on each side of the motorcycle, on the lower leading edge ("chin") of the side fairings. All motorcycles must also display a 1.5 x 3 inch Aprilia logo on either side of the front fairing along side the windscreen. Stickers distributed by clubs.
- 2) A fully completed Race Contingency form must be completed at least one month before the final race of the season and turned in to Aprilia USA in no less than **30 days** from the date of that event. Forms are available at club registration or by calling (877) 277-4542 x135.
- 3) Contingencies will not be paid in any championship with fewer than 3 total entries on the starting grid. Races with fewer than three entries on the starting grid will not be counted.
- 4) All motorcycles must conform to the rules of the assigned class. If for any reason the motorcycle or rider is disqualified from the race, contingencies will be disallowed.
- 5) To qualify for Championship bonus, rider must race Aprilia products exclusively in contingency classes. A minimum completion of three events in 2005 is required.
- 6) Riders falsifying contingency claims will be automatically disqualified from 2005 programs, and may be barred from any further Aprilia contingency programs. Aprilia will not tolerate cheating at any level.
- 7) Program ends 12/31/2005
- 8) No contingencies will be paid without all necessary information including, but not limited to: race results, photographs, copies of any protests involving the applicant.
- 9) Aprilia USA reserves the right to withhold contingency payment until any and all issues regarding the results have been satisfied by the judgment of Aprilia USA.
- 10) Aprilia USA reserves the right to adjust the contingency program to suit class and rules changes up to the first race of the season in each club.
- 11) Racer must race Aprilia Product in all qualifying classes for WERA and CCS

- 1) I acknowledge that I am fully aware of the hazards and dangers involved in motorcycle road racing and understand that an accident could result in permanent injury or death. I hereby assume all risks involved in my participation in this event.
- 2) I HEREBY RELEASE, WAIVE, DISCHARGE, AND CONVENTS NOT TO SUE the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, drivers, pit crews, rescue personnel, any persons in any RESTRICTED AREA, sponsors, advertisers, land owners and lessees of premises used to conduct the EVENT(S), premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding the premises or EVENT(S) and each of them, their directors, officers, agents and employees, all for the purposes herein referred to as "Releasees", FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
- 3) This agreement binds me, my heirs, legatee, personal representatives and all those claiming through me.
- 4) HEREBY AGREES TO FOLLOW ALL RULES SET FORTH IN THE ATTACHED GUIDELINE, and agrees to abide by any penalty (ies) set by the race director/sanctioning body in accordance with the procedure(s) set forth in the rulebook for the current race season.
- 5) I agree to display Aprilia decals on both sides of my bike, at a minimum size of 3x6 inches on the fairing chin, and 1.5 x 3 inch logos on front fairing upper next to windscreen on both sides of bike.
- 6) **I understand that this completed form must be received with verification from the race director within 30 days of the event date** and that falsification of this form will disqualify me from any further 2005 contingency payments including national races and the Aprilia Cup final event. Discrepancies must be addressed within 30 days of payment by written document.
- 7) **Contingency program ends Dec 31 2005.**
